**A RESOLUTION AUTHORIZING EXECUTION OF THE FY2021 BURLINGTON COUNTY
MUNICIPAL ALLIANCE PLAN AGREEMENT BETWEEN THE BOARD OF CHOSEN
FREEHOLDERS OF THE COUNTY OF BURLINGTON AND THE NEW HANOVER TOWNSHIP /
WRIGHTSTOWN BOROUGH MUNICIPAL ALLIANCE
FOR THE FISCAL YEAR PERIOD OCTOBER 1, 2020 THROUGH JUNE 30, 2021
DUE TO THE COVID-19 PANDEMIC**

WHEREAS, the Township of New Hanover is a municipal member of the New Hanover Township/Wrightstown Borough Municipal Alliance along with the Borough of Wrightstown; and,

WHEREAS, the New Hanover Township/Wrightstown Borough Municipal Alliance and the Board of Chosen Freeholders of the County of Burlington have applied for and received a matching grant from the New Jersey Governor's Council on Alcoholism and Drug Abuse in the amount of \$2,167.00 which requires a cash and in-kind match from each municipality; and

WHEREAS, in order to obtain these grant funds, it is necessary that the Borough of Wrightstown certify that matching cash funds in the amount of \$541.75.50 will be provided by the Borough of Wrightstown and that this funding will be provided for in the Borough's 2020 Municipal Budget. It is expected that the Township of New Hanover will thereafter reimburse the Borough for its half share of these funds; and,

WHEREAS, the Borough of Wrightstown agrees to provide an in-kind match in the amount of \$541.75,

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Wrightstown, County of Burlington, State of New Jersey that:

1. The Mayor of the Borough of Wrightstown is authorized to execute the attached Agreement for the New Hanover Township/Wrightstown Borough FY2021 Burlington County Municipal Alliance Plan on behalf of the Borough of Wrightstown for the fiscal period October 1, 2020 through June 20, 2021 due to the COVID-19 pandemic; and

2. The Borough of Wrightstown shall be the lead municipality for purposes of this Agreement and, as such, shall be the party to whom any grant funds disbursed under this Agreement shall be paid and further shall be the party responsible for all fiscal and programmatic responsibilities required by this Agreement; and

3. The Borough of Wrightstown will provide matching cash funds in the amount of \$541.75, half of which it is expected will thereafter be reimbursed to the Borough by the Township of New Hanover, and an in-kind match in the amount of \$1,625.25.
