**RESOLUTION OF THE TOWNSHIP OF NEW HANOVER
AUTHORIZING A CONTRACT WITH CERTAIN APPROVED
STATE CONTRACT VENDOR FOR CONTRACTING UNITS
PURSUANT TO N.J.S.A. 40a:11-12A**

WHEREAS, the Township of New Hanover, pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29©, may by resolution and without advertising for bids, purchase any goods and services under the State of New Jersey Cooperative Purchase program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, the Township of New Hanover has the need on a timely basis to purchase goods or services utilizing State Contracts; and

WHEREAS, the Township of New Hanover intends to enter into a contract with State Contract Vendor Central Jersey Equipment LLC., State Contract Number: A43037 for the purchase of John Deer 4066M Tractor Loader Backhoe through this resolution and properly executed contracts, which shall be subject to all the conditions applicable to the current State contract;

NOW, THEREFORE, BE IT RESOLVED, that the Township of New Hanover authorizes the Purchasing Agent to purchase certain goods and services from the approved New Jersey State Contract Vendors on the attached list, pursuant to all conditions of the individual contracts; and

BE, IT FURTHER RESOLVED, that the Township Committee of the Township of New Hanover pursuant to N.J.A.C. 5:30-5.5(b), the certification of available funds, shall either certify full Maximum amount against available grants or the budget at the time the contract is awarded, or no contract amount shall be chargeable or certified until such time as the goods or services are ordered or

otherwise called for prior to placing the order, and a certification of availability of funds is made by the Chief Financial Officer; and

BE IT FURTHER RESOLVED, that the duration of the contract between the Township of New Hanover and the References State Contract Vendor shall be from February 17, 2017 through February 16, 2020.
