RESOLUTION 2019-89

**RESOLUTION APPROVING CONTINUATION OF
AWARD OF PUBLIC CONTRACT ON EMERGENCY BASIS**

WHEREAS, the Township's current contract for the collection and disposal of solid waste is set to on November 30, 2019 and the Township has advertised for trash hauling services in accordance with the Local Public Contracts Law;

WHEREAS, the responses to the advertisement for trash hauling services in accordance with the Local Public Contracts Law in due on December 19, 2019 and as a result, beginning on December 1, 2019, there will be no contracted vendor in place to provide the necessary services;

WHEREAS, the Township made appropriate arrangements with the existing contractor to provide continuing services on an interim basis until the new contract was awarded so that there would not be any interruption in trash collection;

WHEREAS, pursuant to N.J.S.A. 40A:11-6 et seq. and N.J.A.C. 5:34-6.1 et seq., the situation presented by the expiration of the current trash contract and need to re-advertise for a minimum of sixty days prior to the award of a new contract constitutes an emergency affecting the public health, safety and welfare of the Township residents, and requiring the immediate delivery of goods and/or the performance of services related to the collection and disposal of municipal solid waste; and

WHEREAS, pursuant to N.J.S.A. 40A:11-6 et seq. and N.J.A.C. 5:34-6.1 et seq., the Township and its contracting agent are authorized to award appropriate contracts for

the delivery of such goods and/or the performance of such services without public advertising for bids and bidding therefor, notwithstanding that the contract price will exceed the statutory bid threshold;

WHEREAS, the Township was duly notified of the need for the awarding of emergency contracts in this matter, the nature of the emergency, the time of its occurrence, and the need for invoking N.J.S.A. 40A:-11-6(a) for purposes of awarding contracts for the necessary repairs on an emergency basis;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of New Hanover, County of Burlington, State of New Jersey, that:

1. Pursuant to N.J.S.A. 40A: 1106 et seq. and N.J.A.C. 5:34-6.1 et seq., the Township Administrator is hereby authorized to negotiate and/or award the necessary and appropriate contract for the delivery of goods and/or the performance of services in this matter without public advertising for bids and bidding therefor.
